5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2078/02/21, 14:00 hours** at the office of Sunkoshi Rural Municipality, Sindhuli.

Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format as mentioned which shall be valid for **30 days** beyond the validity period of the bid. If bidder wishes to submit the cash security, the cash to be deposited in **Deposit Account No. 1480100303000002** and submit receipt of deposited amount.
7. If the specified last date of bid document purchasing and submission/ opening falls on a Government holiday then the same time on the next working day shall be considered for such events. However, the last date for bid submission and opening shall be the next working day after the last date of bid purchasing.
